- 1.0 Sealed Tenders are invited for supply of Aux. Engine as per the details furnished in the enclosed schedule.
- 2.0 Technical specifications of Aux. Engine is also attached for ready reference in Annexure-I
- 3.0 In case you are interested, kindly, let us have your most competitive offer in one copy of this tender specification retaining the other for your records. Tenders in any other form or incomplete tenders are likely to be rejected.
- 4.0 The details of the EMD & Tender Document cost should be submitted online and payment receipt should accompany with the tender, without which tender will be rejected
 - a) **EMD:** The Tender must be submitted along with Earnest Money Deposit (**EMD**) for **Rs.92,000.00** (Rupees Ninety Two thousand only) (REFUNDABLE) by depositing the said amount into **Dredging Corporation of India Limited, Current Account No: 35833070000014, IFSC/RTGS CODE: SYNB0003583, SWIFT CODE: SYNBINBB032, BANK NAME: Syndicate Bank, BRANCH NAME: DCI LTD, Port Area Branch, Visakhapatnam- 530001** or by way of BG bond drawn on any Scheduled Bank may be submitted alongwith tender.
 - b) **TENDER DOCUMENT COST:** The Tender must be submitted along with Tender document cost for **Rs. 1,180/-** (One thousand and one hundred and eighty only) (NON-REFUNDABLE) by depositing the said amount into **Dredging Corporation of India Limited, Current Account No: 35833070000014, IFSC/RTGS CODE: SYNB0003583, SWIFT CODE: SYNBINBB032, BANK NAME: Syndicate Bank, BRANCH NAME: DCI LTD, Port Area Branch, Visakhapatnam- 530001.**
- 5.0 The tender shall be governed by the following terms and conditions:
 - 5.01 Tenders should be submitted in sealed cover duly superscribed page nos with the Tender No. and date addressed to General Manager (Ops)/GMP-I, Dredging Corporation of India Ltd., Visakhapatnam - 530 001, so as to reach not later than 1500Hrs. On **16.05.18** Late tenders will not be considered. Local tenderers if so desired may deposit their Tender in the tender box provided for this purpose before due date and time. DCI is not responsible for postal delay.
 - 5.02 Offers submitted vide FAX/EMAIL shall not be considered.
 - 5.03 The tender shall be opened at 1530 Hrs. on the due date i.e. **on 16.05.18** in the presence of such tenderers who are present at that time to witness the opening of the bids.
 - 5.04 All tenders must be absolutely clear and qualified failing which the same will not be considered.

- 5.05 All columns should be properly and legibly filled in and no column should be left blank. Any correction in the rates etc., should be duly attested by the Tenderer. Alterations not authenticated with attestation may result in rejection of tender. Prices should be quoted in Indian Rupees only.
- 5.06 Any revision of rates after opening of the tender will not be accepted.
- 5.07 The offer should be kept open for acceptance for three months (90 days) from the date of opening of the tender.
- 5.08 The supply of Aux. Engine (DG Set) should accompany with Manufacturer's Manual/ brochures etc., Hence, the charges if any may be specified, failing which it will be presumed that the rates have been offered are inclusive of all above.
- 5.09 Only basic rates should be quoted. The terms of price, details of packing/ forwarding charges and any other charges should be clearly indicated separately, failing which it will be presumed that the rates have been offered inclusive of all above charges.
- 5.10 GST as applicable shall be payable extra wherever applicable. The Percentage of GST prevailing should be indicated with HSN Code separately failing which it will be considered as the rates are inclusive of all taxes and duties. **We do not have Sales tax declaration form 'C' or 'D'** to issue.
- 5.11 Requirement of Aux. Engine (DG Set) is very urgent thus the delivery term is essential. Hence delivery of the materials required strictly within **60 Days** from the date of purchase order. Please note that the tenderer who is in a position to deliver / supply the required Aux. Engine with in the above specified period, their offer will only be considered.
- 5.12 Party / supplier should attend for the installation & commissioning of the Engine onboard at any Indian Seaport.
- 5.13 100% payment will be made within 30 days from the date of receipt of materials, installation, commissioning and satisfactory full load trials on board the dredger along with documentation in full subject to submission of invoice complete in all respects.
- 5.14 Make/Brand of the Aux. Engine (DG Set) offered should be specified without fail. All Relevant Catalogue/Literatures should be submitted along with Tender.
- 5.15 The offers should be specify whether they are manufacturers, authorized Agents/dealers/ suppliers for the DG Set offered.
- 5.16 For patent items, Corporation reserves the right to demand submission of materials price Lists.
- 6.0 Samples whenever asked for should be made available for inspection by DCI officials.
- 7.01 Earnest Money Deposit will be refunded to the unsuccessful tenderers within 15 days after finalizing of tender. EMD of successful tenderers will be returned only on receipt of security deposit/performance security specified in the tender.
- 7.02 The EMD will be forfeited in favour of Dredging Corporation of India Ltd., if the tenderer backs out after opening of tenders or after Corporation communicates its acceptance of offer/ quotation or if the tenderer modifies the tender after opening.
- 8.0 Performance Security: The Tenderer should submit 10% of the tender/contract value by depositing the said amount into Dredging Corporation of India Limited, Current Account No: 35833070000014, IFSC/RTGS CODE: SYNB0003583, SWIFT CODE: SYNBINBB032, BANK NAME: Syndicate Bank, BRANCH NAME: DCI LTD, Port Area Branch, Visakhapatnam- 530001 **or** by way of BG bond drawn on any Scheduled Bank within 10 days on receipt of communication and the same will be returned only after expiry of the manufacturer's warranty. The BG bond should be valid for the entire warranty period plus additional/extra six (6) months for due fulfilment of warranty obligations. (BG format attached).

- 9.0 After award of purchase order, if the supplier fails to complete in full or any part thereof within the prescribed delivery period, the Corporation reserves the right:
- A) To recover from the supplier, liquidated damages and not by way of penalty, a sum not less than 1% of the value of order or portion thereof which the supplier failed to complete as aforesaid, for each week or part of a week subject to maximum of 10% of basic material cost during which the completion of such order may be in arrears.
 - B) To cancel the order or portion thereof, and if so decided, to process a fresh order on alternative sources at the risk and cost of the supplier. The manner and method of such purchase shall be in entire discretion of the Corporation.
- 10.0 The bidders shall give an undertaking that they have not made any payment or illegal gratification to any person/authority connected with the bid process so as to influence the bid process and have not committed any offence under the prevention of corruption act in connection with the bid.
- 11.0 The bidders shall disclose any payments made or proposed to be made to any intermediaries (agents etc.) in connection with the bid.(Undertaking letter at annexure is attached).
- 12.0 The Corporation reserves all rights to accept or reject any tender in part or in full without assigning any reason thereof.
- 13.0 a) ARBITRATION AND JURISDICTION ARBITRATION: In the event of any question or dispute arising under these conditions of contract or in connection with this contract (except as to any matters the decision of which is specially provided for by those conditions), the same shall be referred to the award of an Arbitrator to be nominated by the reporter and an Arbitrator to be nominated by the contractor or in case of the said appointed by the arbitrators in writing within one month after the appointment by both the arbitrators and decision of the umpire appointed by them shall be final and conclusive and the provision of India Arbitration Act 1996 and of the rules, the retender and any statutory modification thereof, shall be deemed to apply to and be incorporated in this contract.
- b) LAWS GOVERNING THIS CONTRACT: This contract shall be governed by the laws of Union of India for the time being in force. All disputes arising out of or under the contract will be subject to the jurisdiction of the Courts of Visakhapatnam only.

- 15.0 The tender will be finalized on L1 basis.
