4. The offer should be valid for a period of 90 days (ninety) days from the date of opening.
5. DCI reserves the right to cancel/withdraw the tender at any stage without assigning any reason.
6. Conditional offers and additional conditions of the offerer if any will not be considered.
7. **ARBITRATION:** In case of dispute between DCI and Contractor for contract up to Rs.10 Crores the issue will be referred to Chief General Manager (CGM), Dredging Corporation of India Limited and the decision of CGM, shall be final, conclusive and binding on all the parties and the contract upon all question relating to the meaning of the specifications, designs, drawings and instructions and as to the quality of workmanship, or materials used on the work or any matter arising out or relating to the specifications and instructions concerning the works or the execution or failure to execute the same arising during the course of work.
